



Research shows that children who have wishes granted can build the physical and emotional strength they need to fight a critical illness.

A wish also gives children renewed energy, brings families closer together and unites communities.

The Wish Fulfillment Process

We meet families at a time when they are struggling with uncertain medical outcomes for their children.

Wish referrals may come from almost anyone-doctors, nurse practitioners, social workers or other health care professionals, parents, friends, neighbors, teachers, clergy or even the wish child him/herself.

Make-A-Wish Georgia works closely with medical professionals at pediatric facilities across the state to ensure that children who medically qualify are given the opportunity to receive a wish.

Once a child medically qualifies for a wish, the dreaming begins. Two local volunteers are assigned to every wish family to learn the child's one true wish.

Wishes generally are one of these five types:

- I wish to go
- I wish to meet
- I wish to have
- I wish to be
- I wish to give

Once that wish is known, staff wish coordinators begin designing and curating an extraordinary wish experience that includes the entire wish family household.

On average, the multi-step wishgranting process takes 9-12 months from the time that a child is referred to the time that his/her wish is granted. Make-A-Wish Georgia takes care of all wish-related expenses and travel logistics so that families can be fully present in the moment during their child's actual wish experience.

The goal of the wish experience is for families to spend quality time together doing something fun, relaxing/exciting and memorable that takes focus off the wish child's illness.

The Need

To date, we have granted over 200 wishes during a worldwide pandemic, but some of our children chose to wait, 750 of them to be exact. These children's true heartfelt wish was to travel to Disney or New York or Hawaii, and they were willing and able to wait for us to make that dream come true.

While travel wishes, as well as wishes involving large crowds, are currently on hold, we remain dedicated to being a source of joy for wish kids and their families. Presently, we are granting wishes we know keep our families safe, such as wishes "to have." We also remain engaged with families awaiting their wish day and are continually discovering new ways to provide hope and joy in these difficult days. We are on the cusp of being able to grant the wishes on hold, but in order to do so, we need your help! As soon as it is safe to travel for these families, we will need to quickly grant all of the wishes that have been postponed due to the pandemic. We anticipate needing to grant a record-breaking 1000 wishes over the next two years, requiring \$1.5M of additional funding.

Currently, we have identified six (6) children from the multi-county area served by EMC who are waiting to receive wishes: one in Baker County, one in Dougherty County, three in Mitchell County, and one in Worth County. Half of these children have determined their heartfelt wish, while several more wish kids are still deciding on what their heartfelt wish will be.

We have always believed our purpose is to create hope through wishes; as COVID-19 elicits new challenges for our families, hope is more crucial than ever before. While it remains uncertain when we will be able to resume granting wishes involving travel or large gatherings, your support now will ensure that we will be ready to grant the wishes on hold and bring joy and hope to kids who need it the most.

Except for rush wishes, which are always fulfilled as quickly as possible, families are informed that most wishes will be granted within 9-12 months. For children who wish to go, they can either postpone their wish until the pandemic is lifted or change their wish.

Note: Project Budget is based on six (6) wishes currently pending in Baker (1), Dougherty (1), Mitchell (3), and Worth (1) counties as of 5/5/2021. For the three (3) travel wishes that are "determined," projected wish cost is based on FY 2020 average cash and in-kind wish expenses by wish type. For the three (3) wishes that are "yet to be determined," wish cost is estimated based on FY 2021 Q2 projected average cash and in-kind wish expenses across all wish types.

Other Sources: Contributions not restricted (by a donor) to a particular geographic region support the organization's wish-granting efforts across the state including in EMC's multi-county service area. Fund raising for the wish-granting program is ongoing with appeals to local foundations, corporations and individuals.

Our Request

Will the Foundation consider a \$10,000 gift to help us fund components of multiple children's wish expenses during the funding period?

We anticipate that the cost to grant all six (6) of the current children's wishes when it is safe to do so is approximately \$51,469 (\$25,816 in cash costs plus \$25,653 in in-kind costs).

Your \$10,000 gift will be applied to wish family wish expenses, such as wish enhancements (e.g., props, costumes, wish theme-related materials, etc.) and wish celebrations. Then as soon as it is safe to do so, funds can be immediately directed to help cover the cost of wish expenses such as airfare, hotel accommodations, and the like.

In exchange for your gift, Make-A-Wish Georgia would look forward to sharing with the foundation the children's wishes you helped to make possible. This includes any wish photos and/or family testimonials shared with us by families following their completed wish experience.

Benefits of a Wish Experience

While we've long known anecdotally that a wish can play an important role in a child's emotional and physical journey back to health, emerging scientific studies confirm a positive correlation between wishes and improved health outcomes. In a first-of-its-kind study. Nationwide Children's Hospital examined qualify of life and health care utilization among 992 pediatric patients evaluated between 2001 and 2016. The study consisted of one group who received a wish and a control group who did not. Patients in the study had critical illnesses across disease categories, including 44.8% with cancer. Dr. Anup Patel, the study's principal investigator, found that children who were granted a wish were more likely to have better health outcomes, including fewer unplanned hospital and emergency department visits. Wishes also helped build care compliance. These findings open the door to possible medical (and financial) benefits should wishes one day become part of the treatment protocol for all children battling a critical illness. A considerable body of research already demonstrates that children can and do benefit from participating in interventions that reduce the feelings of hopelessness associated with fighting a critical illness. By supporting wishes, you will be helping us extend the benefits of a wish experience to the kids who need it most.

Evaluation & Outcomes

To ensure that the wish process is a positive experience for everyone involved, we survey wish families within 30 days of their child's completed wish. The survey is designed to elicit qualitative and quantitative feedback on every aspect of the wish experience from the planning process through fulfillment of the wish. Our goal is always not just to meet, but to exceed, the wish child's wildest expectations. We also evaluate program success by the total number of wishes we're able to grant each year relative to our annual impact goal.

Based on previous surveys, we know a wish has the power to improve physical and mental health, not only for a wish kid, but also for their family. 89% of medical professionals believe a wish experience can positively influence a child's health and 71% of surviving wish kids state that their wish experience contributed to saving their lives. Additionally, 98% of parents agreed that the wish generated a sense of hope, an improved outlook, and enhanced the mental and emotional health of their child.

Capacity to Carry Out Program

In Georgia, 400+ trained volunteers statewide, an active Board of Directors, and 30+ passionate staff members support the fulfillment of our mission. Make-A-Wish Georgia has built solid working relationships with the medical community across the state, acknowledging that these relationships are essential to reaching medically eligible children. The chapter works to ensure that our funding sources are diversified to reduce financial risk and ensure program sustainability. As responsible stewards, we strive to keep administrative and fundraising costs to a minimum so that the majority of every donor dollar goes directly towards wish granting.

Program Purpose

We are committed to bringing these wishes to life because every child deserves a moment that changes everything. Join our mission today by helping us make every wish come true. Together, we will continue to be a light of hope throughout this crisis... and beyond!


